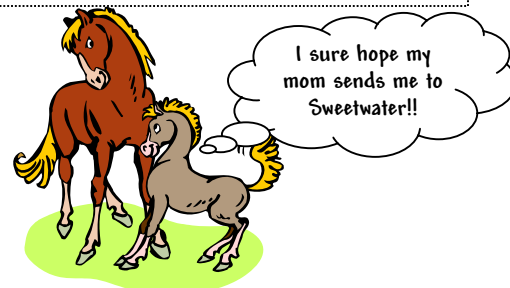

### Day Camps

#### Camp Fee: \$475/session

- Fee includes a \$200 non-refundable deposit.
- Special Rate of \$450 for early registration on or prior to March 1st, 2008.
- *Spring Camp*, deposits are accepted though March 1, 2008 with balance due March 15th, 2008.
- *Summer camp*, deposits are accepted though May 15, 2008 with balance due June 1<sup>st</sup>, 2008.
- *Summer Camp*, after May 16, 2008 registration in full is required to reserve your camp.
- Extended care is offered. See page 2.

# Terms for the 2008 Season Day Camp Enrollment

**Age Requirements:** Campers must be between the ages of 7 & 15 during their camp session.

**Upon Receipt of Registration:** Each camper will receive an enrollment confirmation by mail. If you have not received your confirmation packet within 10 business days please call the Camp office to confirm receipt of your registration.

**Liability Release Forms:** All campers are also required to have a current Liability Release Form on file in the Camp office during their stay. The form will be included with your confirmation packet or can be down loaded off our website [www.sweetwaterhorses.com](http://www.sweetwaterhorses.com) and included with your registration and payment. **The Liability Release Form must be in our office by March 15, 2008 for Spring Camp and June 1, 2008 for Summer Camp.**

**Dismissal of Camper:** The camp reserves the right to dismiss, in it's sole discretion, any camper whose condition, conduct, influence, or behavior is deemed unsatisfactory or detrimental to the best interest of the Camp or her/his fellow campers or who violates Camp rules and regulations, in which case no refunds will be made.

**Extended Care:** This is a service that is provided for campers who because of transportation issues need to arrive at camp early and/or stay after camp is over. This service needs to be reserved and paid for in full by June 1, 2008. There are no refunds and it CANNOT be added after your camper begins camp. Extended Care Hours and Cost per session: 7-9am \$50, 4-6pm \$50, \$95 for morning and afternoon. *Please Note: campers not on extended care should be picked up no later than 4:15. Parents will be charged \$1 per minute after 4:15 for campers not picked up.*

**Late Arrival/Early Departure:** No reduction in enrollment fees will be made for late arrival or early departure of camper.

**Medical:** Parent grants permission to utilize medical treatment should the camp staff deem such treatment necessary for the well being of the camper. Said parent will pay all medical expenses involved. Parent understands this camp does not provide medical insurance of any kind for the camper.

## **Waiting Lists:**

Registrations are accepted on a first come, first serve basis. When all available spaces are full a wait list will be created.

## **Please Read: Cancellation Policy:**

The camp fee includes a \$200 per session non-refundable/non-transferable deposit. For any cancellation received prior to final payment deadline, the camp fee will be refunded minus the non-refundable deposit (\$200 per session). **In order to provide the highest quality horse program we must plan well in advance based on confirmed reservations. For that reason, after the final payment date for your child's camp session no refunds will be issued for cancellations.** Final payments for spring camp will be due on/before March 15th. Final payments for summer camp sessions will be due on/before June 1st.
